Please be aware of the following rules regarding exhibiting in the Show! These are mandatory and will benefit your experience.

 _ I MUST abide by the signage rules and regulations as per my booth dimensions OR have pre-approval from Show Management.
 I MUST stay completely within the dimensions of my booth without protruding into the aisles or into other Exhibitors' booth space.
 _ I MUST not share my exhibit space with another entity. I understand that each exhibit is restricted to the products & services contracted.
 _ I MUST provide carpet or other clean, appealing flooring that covers the entire dimensions of my booth either by renting from the show decorator or providing my own.
 _ I MUST not dismantle my booth or begin packing up product prior to show close at 6pm on Sept. 24, 2017.
 I MUST professionally drape and skirt any tables used in my booth either by renting them from the show decorator or providing my own. I understand that bed sheets and plastic tablecloths are not permitted.
 _ I MUST have the backside and sides of my booth professionally finished (if exposed).
I MUST have a fire extinguisher and functional smoke detector if my exhibit features an enclosed space such as a garage, shed, etc. or if it features a cooking demonstration.
 I MUST ensure that all vehicles within my exhibit: contain 1/4 tank of gas or 20 liters, whichever is less. I understand that the keys must remain onsite, the battery must be disconnected and the gas cap taped closed.
 _ I MUST not bring any helium balloons, peanuts (in the shell) or popcorn into the Show.
 I MUST use a fire retardant protective coating (such as plastic) to protect the floor and all facility equipment if my booth display contains any soil, mulch, or similar materials.
 _ I MUST receive approval for my hanging signs/objects over 20 lbs. from Calgary Stampede Event Services and my Exhibit Sales Consultant.
 _ I MUST obtain pre-approval from Show Management if my display is over 8 ft.
I MUST have a permanently attached label indicating conformance to CAN/ULC-S109 on any tents and canopies in m booth space; as per the Calgary Fire Department Indoor Special Events Requirements Guide. I understand that any tents or canopies without the proper labelling will be removed from the show floor immediately.
